

  Members of the Adileela Foundation.
- (4) No members of the Foundation shall have any personal claim on any moveable and / or immovable properties of the Foundation or make any profit, whatsoever, by virtue of his membership.
- To Hire / Purchase / Accuire land for the Foundation and to construct building thereon for the cause of the Foundation.
- To honor and give prizes, momentos and Awards, Facilitation for outstanding services rendered in any field in India and Abroad.
- To arrange and organize social, cultural and Educational, Social Programmes and functions from time to time including get together picnic, celebration and seminars and shows for the members and invitees of the Adileela Foundation.
- Adileela Foundation will take up with the industry all the matters with all painful effect and also the causes of the people for the upliftment.
